#### **Definitions**

- I. "Solar" means the Inverter is used in a solar energy system with the inverter/charger's Inverter parameters set according to AutoX's data sheets, specifications and application instructions as contained in the Technical Documentation.
- II. Reserve power/Standby power means the Inverter is used in a back-up power system such as an UPS (Uninterrupted Power Supply), with the Inverter parameters set according to AutoX's data sheets, specifications and application instructions as contained in the Technical Documentation.

# **ANNEXURE 1: Warranty periods**

## 1. Rentech Jaguar, BBox, Axpert, Oryx and InfiniSolar V inverters:

- a. 18 (eighteen) months from date of purchase or 2 (two) years from date of manufacturing whichever comes first.
- 2. Rentech Infinisolar Plus inverters: 6 (six) months from date of purchase.
- Rentech supplied SofarSolar inverters and Rentech branded SofarSolar HYD-5000-EP inverter:
  - a. As per the "SOFARSOLAR Warranty Terms and Conditions" which apply in addition to the AutoX Inverter General Warranty Terms and Conditions:
    - i. Inverters 5 (five) years from date of purchase or 5.5 years (66 months) from date of manufacturing whichever comes first
    - ii. Accessories 2 (two) years from date of purchase or 2.5 years (30 months) from date of manufacturing whichever comes first.

#### 4. Rentech supplied Sunways inverters:

- a. As per the following Sunways documentation which apply in addition to the AutoX Inverter General Warranty Terms and Conditions:
  - i. "Sunways Warranty Terms and Conditions":
    - Standard manufacturer's warranty of 60 months (5 years) from the earlier date between the following two dates: 1) first installation date; 2) 6-months after the shipment dispatch from Sunways factory.
    - Accessory products including but not limited to WiFi module, GPRS module, LAN module, Data logger and CT etc come standard with a manufacturer's warranty of 24 months (2 years) under the same conditions.
  - ii. "Sunways Terms of Use EN";
  - iii. "Sunways Privacy Policy EN".
